Procedure

Step	Process
1	Mix phase A ingredients together and heat to 85°C.
2	Slowly add phase B to phase A with increasing mixing speed little by little (400 to 1000 rpm), then mix at 2000 rpm during 5 minutes.
3	Let cool it down to 30°C with mixing.
4	Mix phase B ingredients together and heat to 85°C.
5	Add phase C with mixing.
6	Add phase D with mixing.
7	Add phase E while mixing.
8	Add phase F with mixing.
9	Homogenize using a high shear mixer (Ultraturrax or Silverson type).

Stability

Formulation is stable for 1 month at RT and 40°C.
