1	Mix phase A ingredients and heat to 85°C for 10 min.		
2	Premix phase B until homogeneous.		
3	Add phase A to phase B with gentle mixing.		
4	Cool to RT.		
5	Premix phase C until homogeneous.		
6	Slowly add phase C to blend AB under turbulent mixing.		
7	Mix for an additional 5 minutes at 2000 rpm.		
8	Add phase D and mix at 2000 rpm for 5 minutes.		
9	Homogenize using a high shear mixer.		
10	Add phase E while mixing.

Stable for at least 3 months at room temperature and 40°C.
